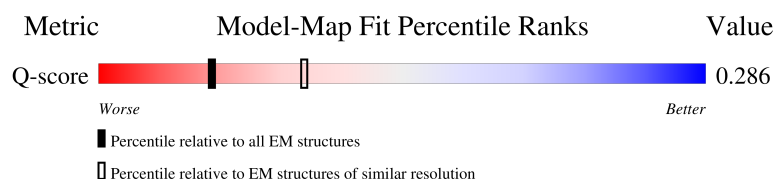
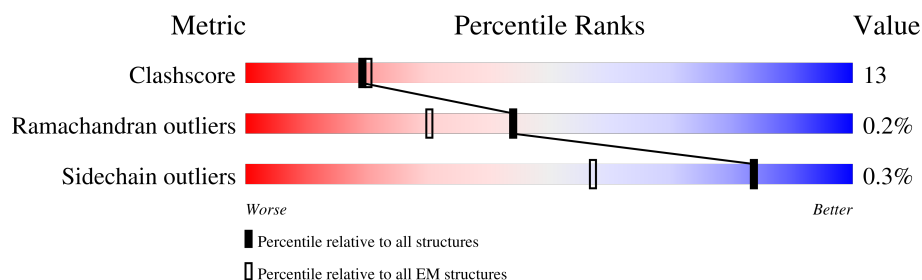
1 Overall quality at a glance i

The following experimental techniques were used to determine the structure:

ELECTRON MICROSCOPY

The reported resolution of this entry is 4.30 Å.

The red, orange, yellow and green segments of the bar indicate the fraction of residues that contain outliers for ≥ 3 , 2, 1 and 0 types of geometric quality criteria respectively. A grey segment represents the fraction of residues that are not modelled. The numeric value for each fraction is indicated below the corresponding segment, with a dot representing fractions $\leq 5\%$. The upper red bar (where present) indicates the fraction of residues that have poor fit to the EM map (all-atom inclusion $< 40\%$). The numeric value is given above the bar.

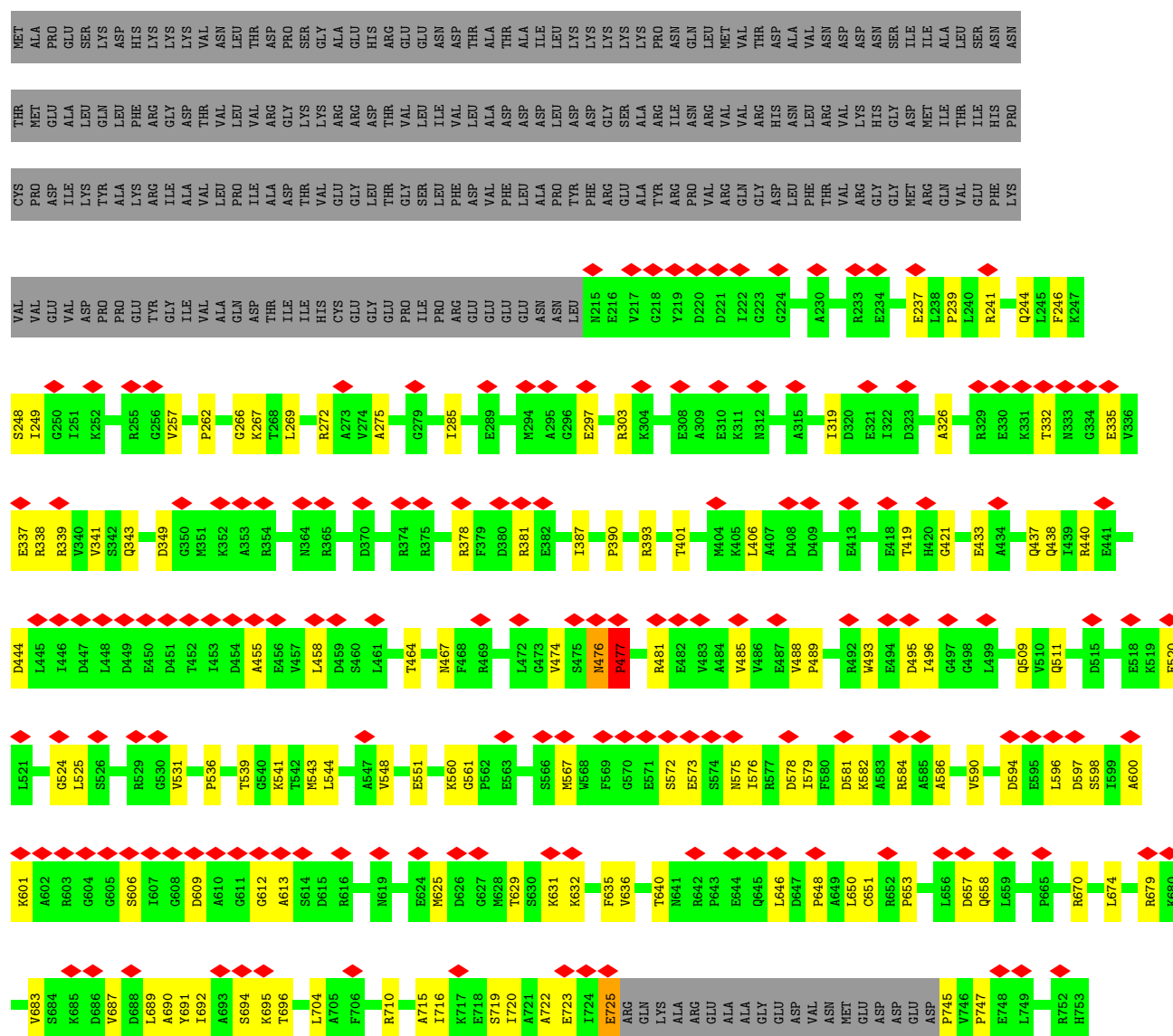


• Molecule 2: Putative cell division control protein

5.1 Standard geometry

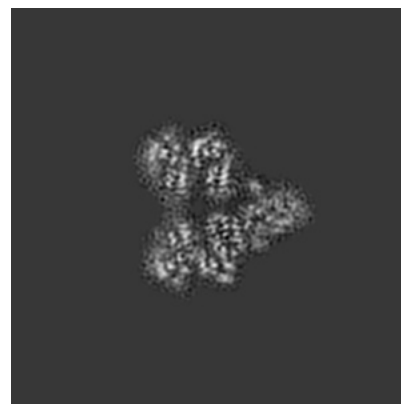

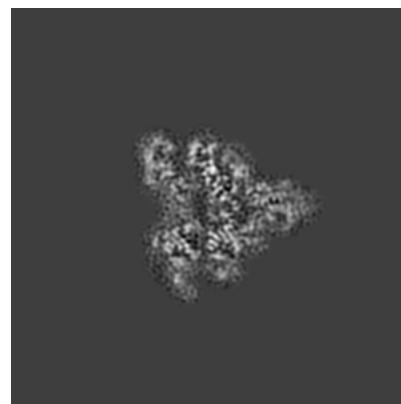

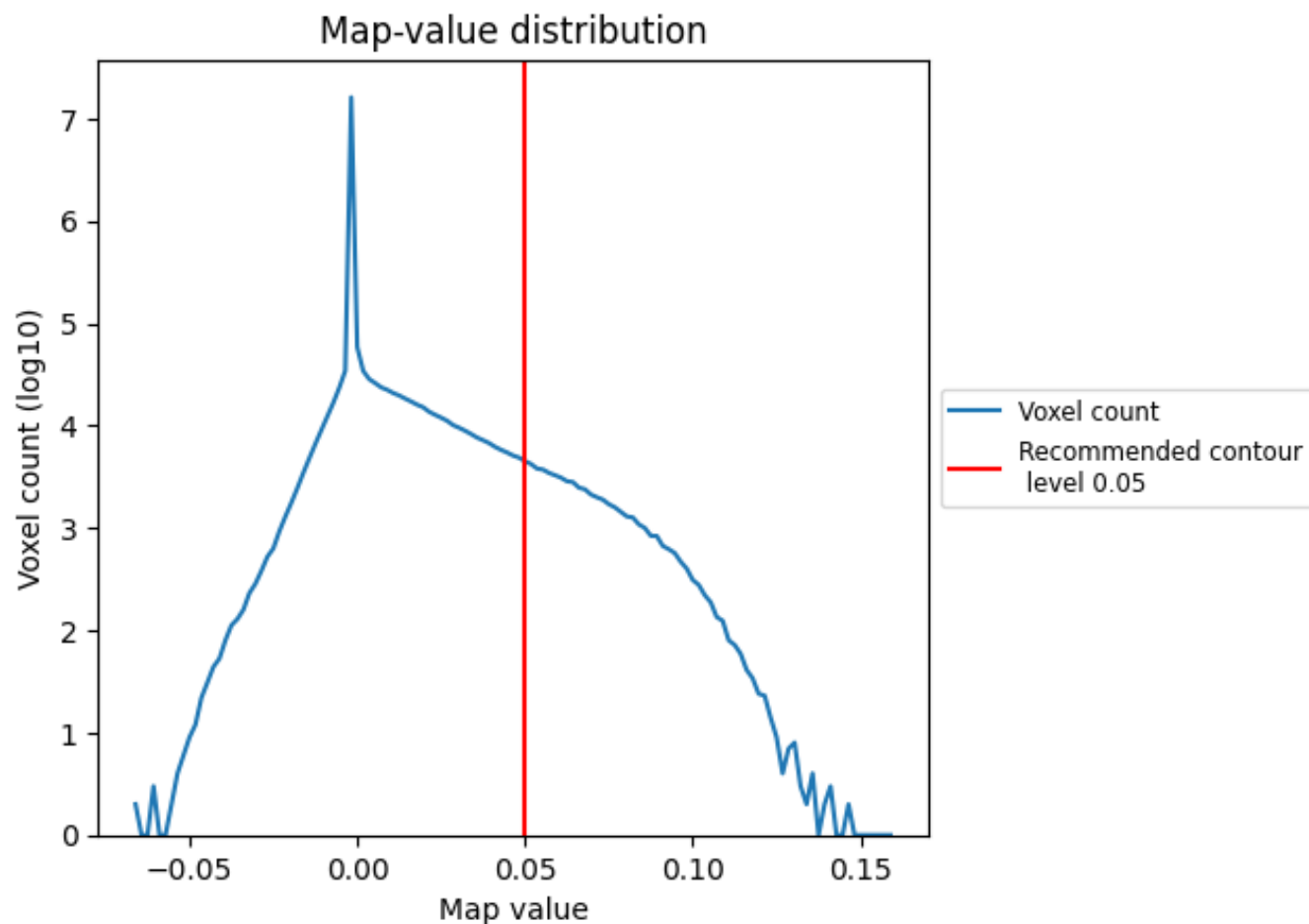

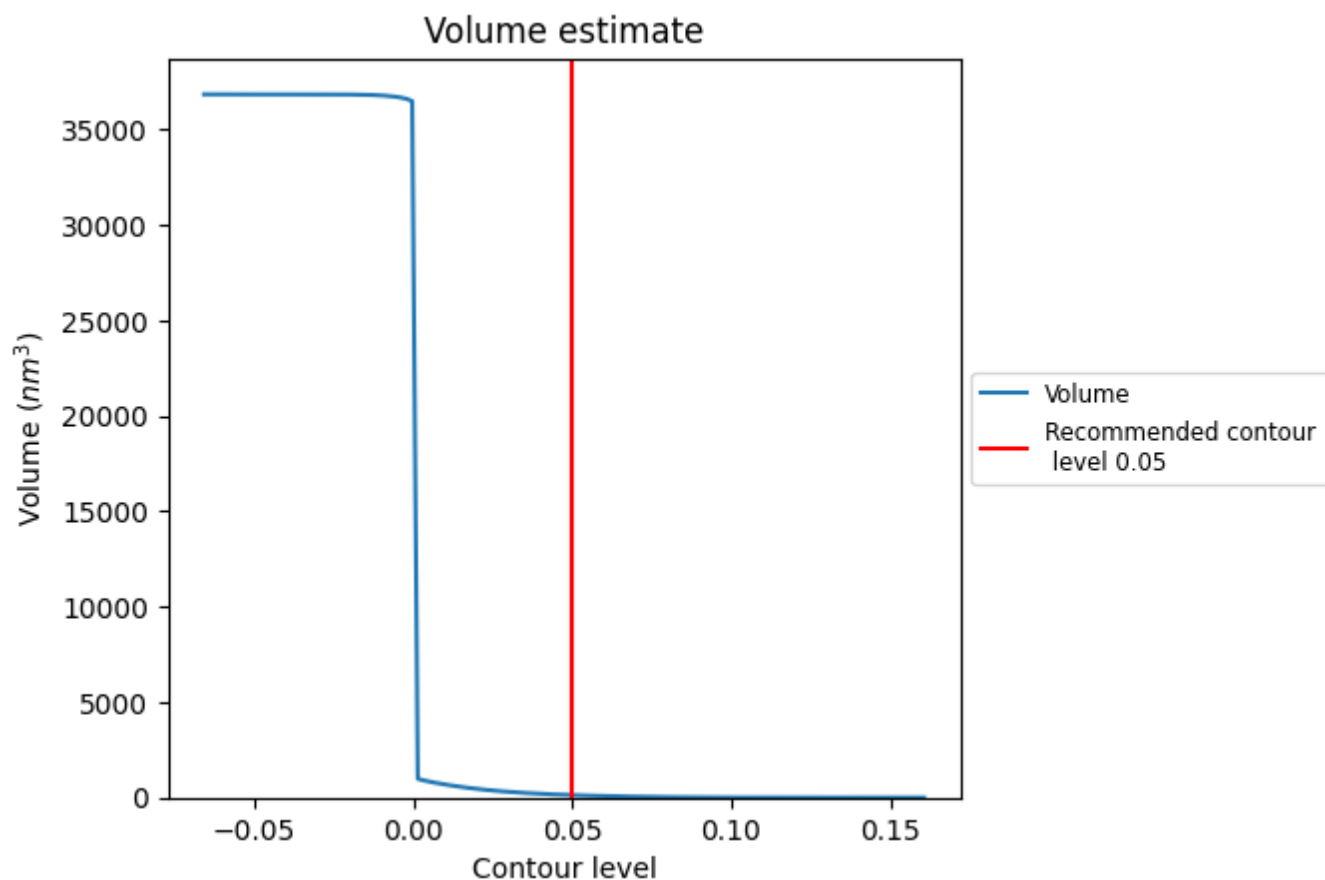

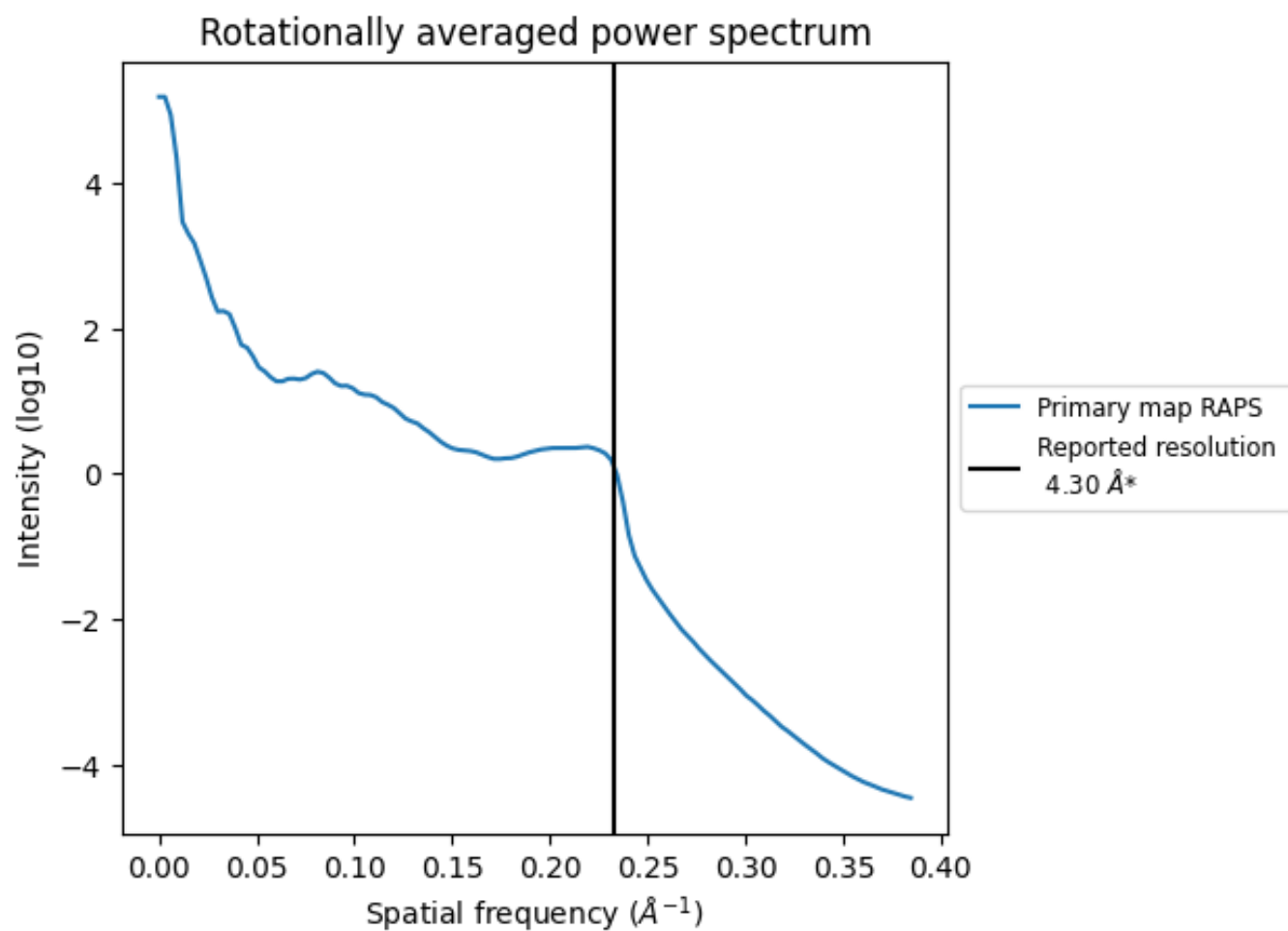

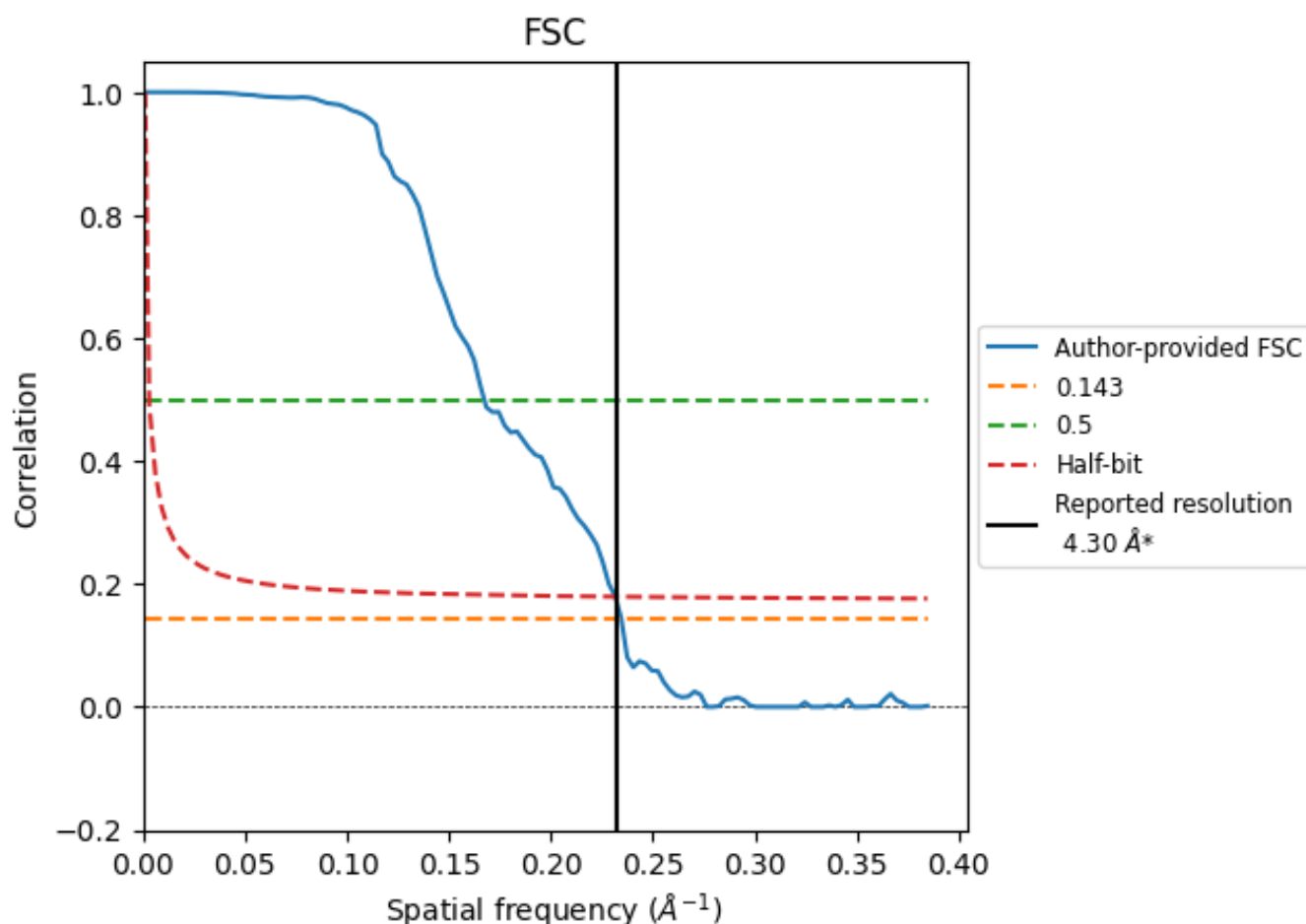

9.2 Q-score mapped to coordinate model [i](#)



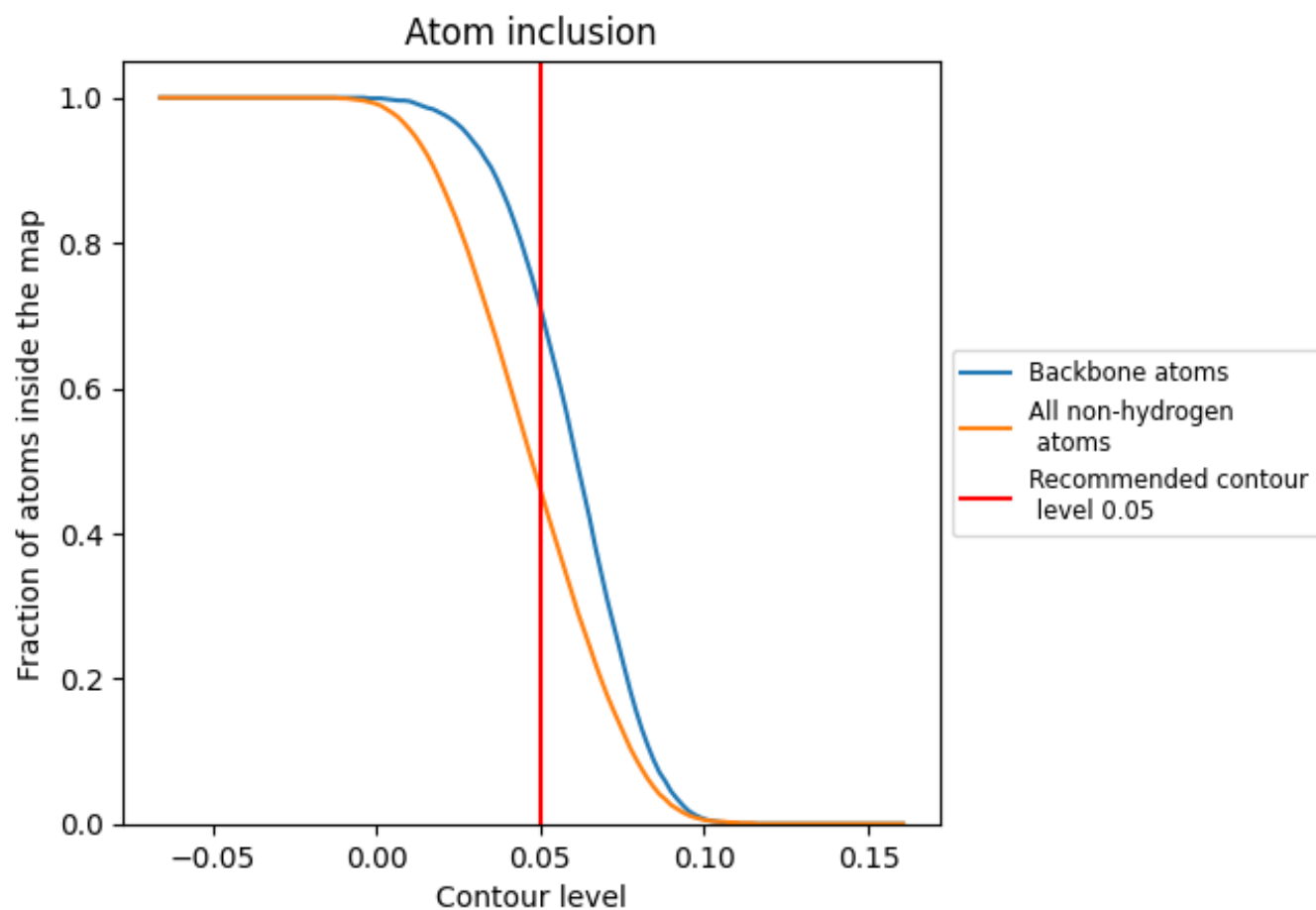

At the recommended contour level, 71% of all backbone atoms, 46% of all non-hydrogen atoms, are inside the map.
