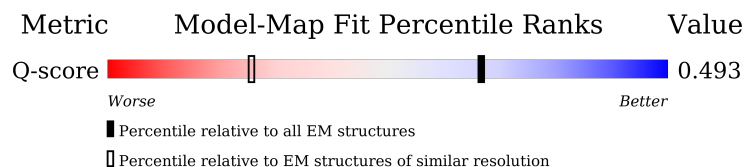
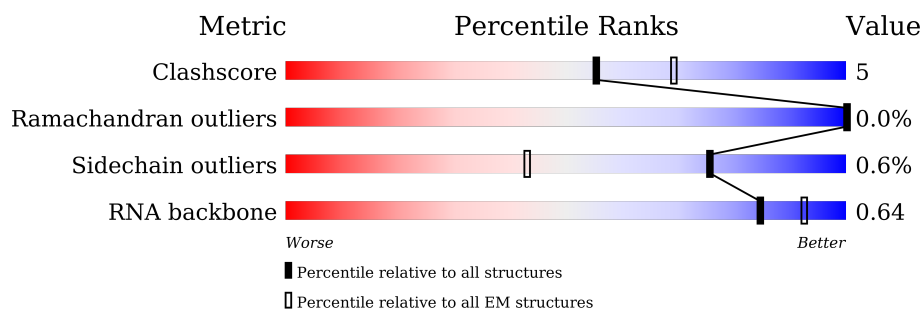
# 1 Overall quality at a glance

The following experimental techniques were used to determine the structure:

*ELECTRON MICROSCOPY*

The reported resolution of this entry is 2.56 Å.

The table below summarises the geometric issues observed across the polymeric chains and their fit to the map. The red, orange, yellow and green segments of the bar indicate the fraction of residues that contain outliers for  $\geq 3$ , 2, 1 and 0 types of geometric quality criteria respectively. A grey segment represents the fraction of residues that are not modelled. The numeric value for each fraction is indicated below the corresponding segment, with a dot representing fractions  $\leq 5\%$ . The upper red bar (where present) indicates the fraction of residues that have poor fit to the EM map (all-atom inclusion  $< 40\%$ ). The numeric value is given above the bar.

## 2 Entry composition

There are 18 unique types of molecules in this entry. The entry contains 32480 atoms, of which 0 are hydrogens and 0 are deuteriums.

In the tables below, the AltConf column contains the number of residues with at least one atom in alternate conformation and the Trace column contains the number of residues modelled with at most 2 atoms.

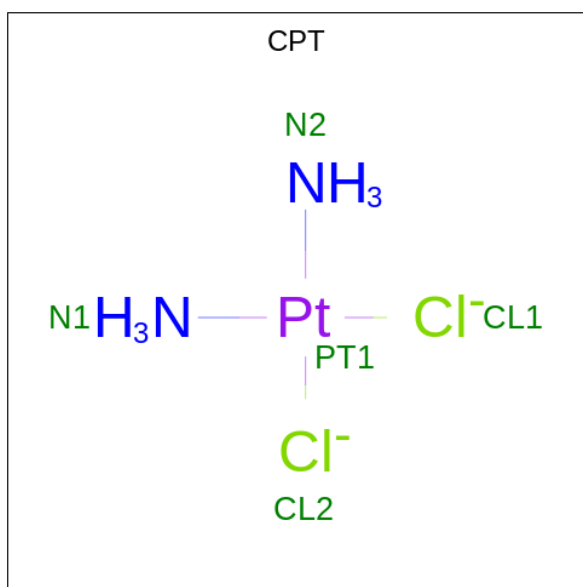

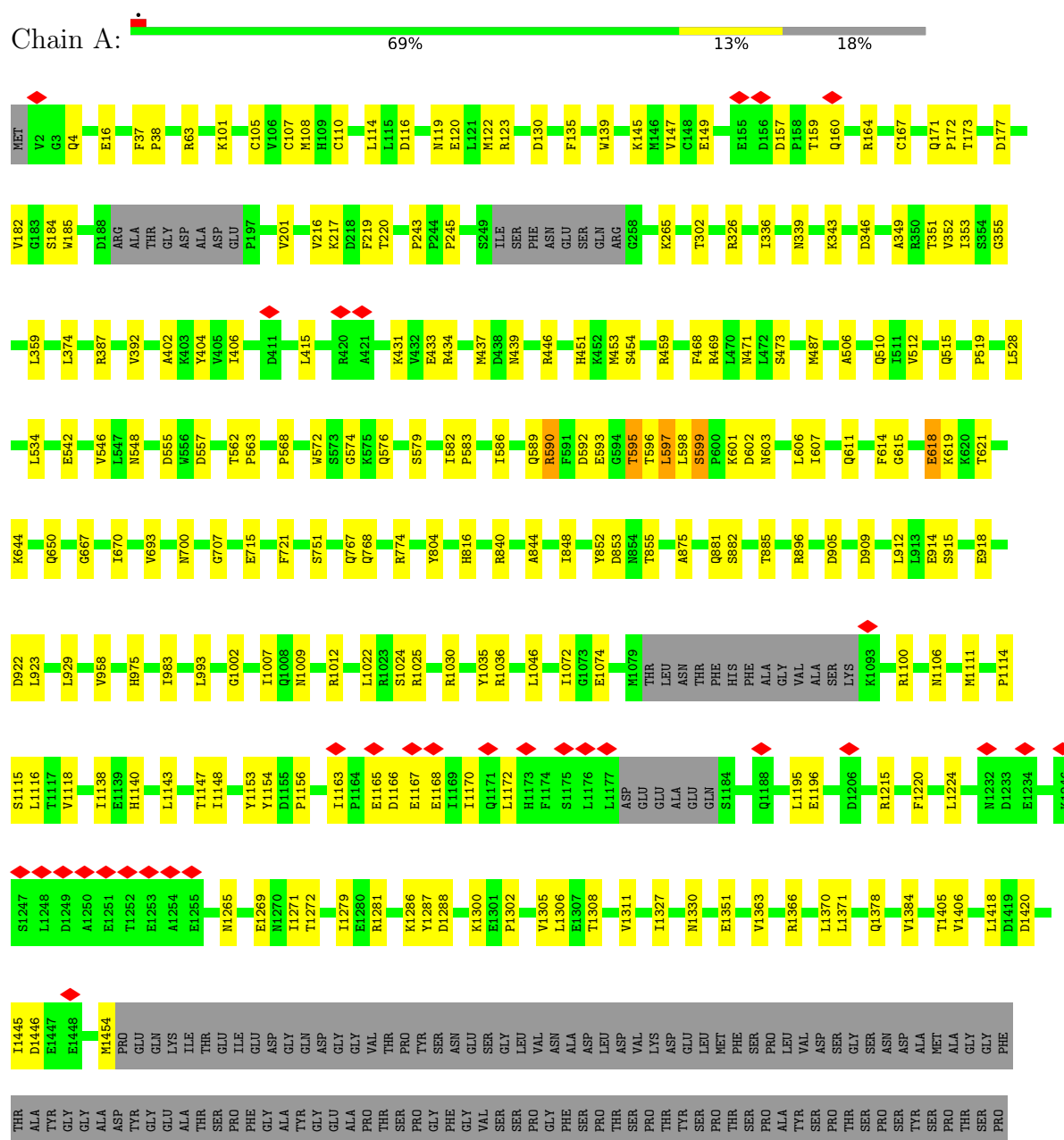


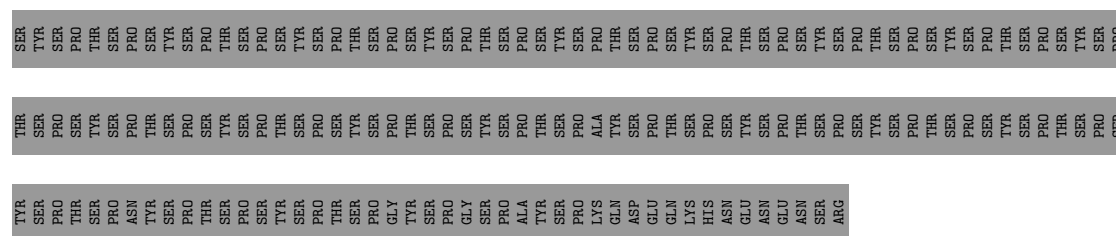

### 3 Residue-property plots

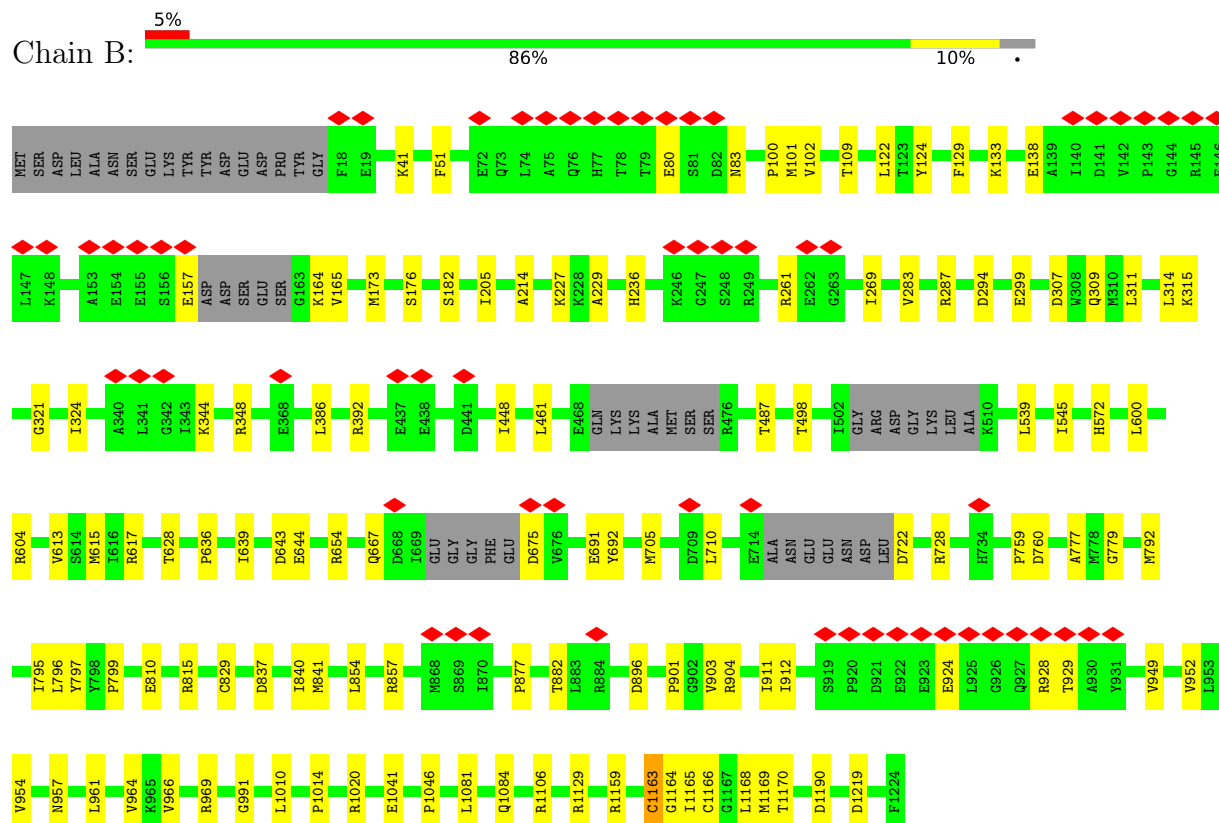
These plots are drawn for all protein, RNA, DNA and oligosaccharide chains in the entry. The first graphic for a chain summarises the proportions of the various outlier classes displayed in the second graphic. The second graphic shows the sequence view annotated by issues in geometry and atom inclusion in map density. Residues are color-coded according to the number of geometric quality criteria for which they contain at least one outlier: green = 0, yellow = 1, orange = 2 and red = 3 or more. A red diamond above a residue indicates a poor fit to the EM map for this residue (all-atom inclusion < 40%). Stretches of 2 or more consecutive residues without any outlier are shown as a green connector. Residues present in the sample, but not in the model, are shown in grey.

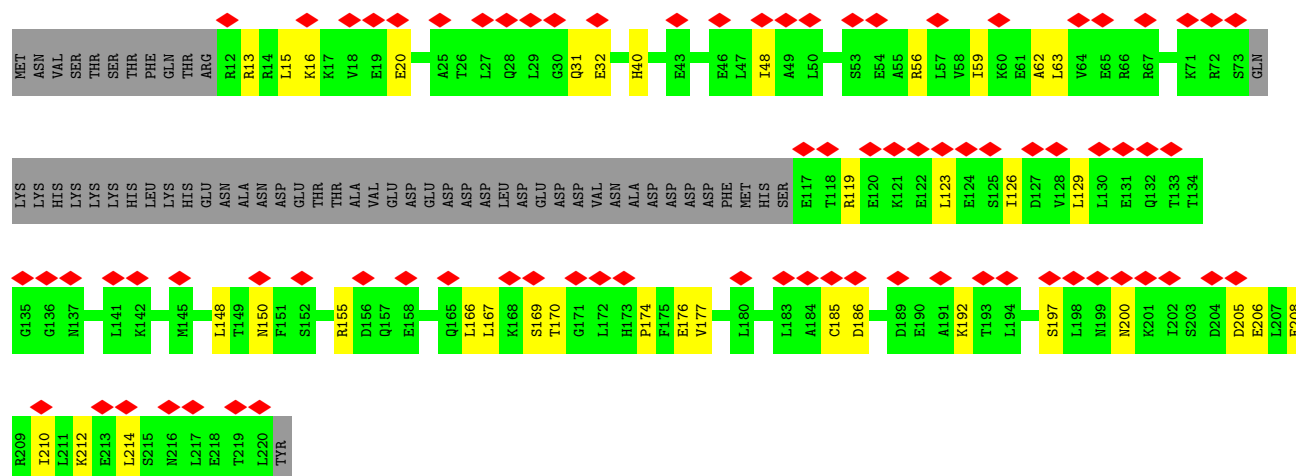
#### • Molecule 1: DNA-directed RNA polymerase II subunit RPB1



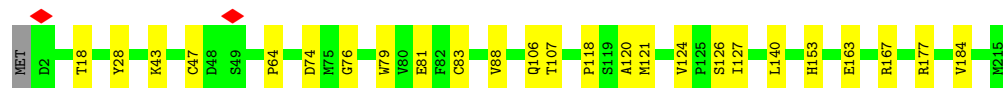
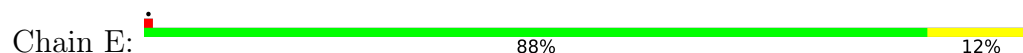


• Molecule 2: DNA-directed RNA polymerase II subunit RPB2

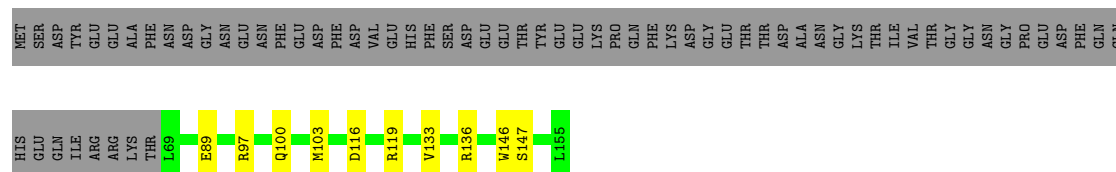




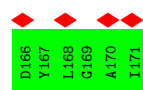
- Molecule 5: DNA-directed RNA polymerases I, II, and III subunit RPABC1



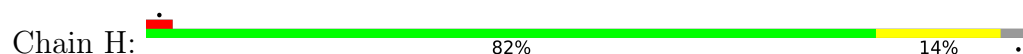
- Molecule 6: DNA-directed RNA polymerases I, II, and III subunit RPABC2

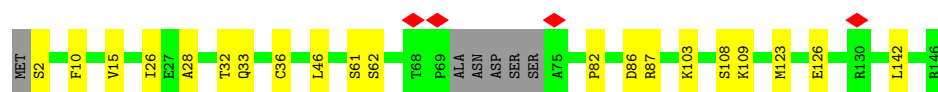


- Molecule 7: DNA-directed RNA polymerase II subunit RPB7

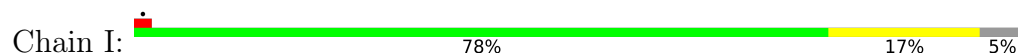


- Molecule 8: DNA-directed RNA polymerases I, II, and III subunit RPABC3

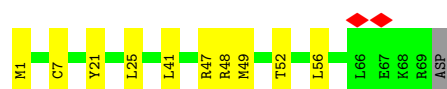
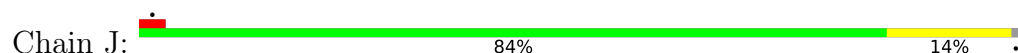




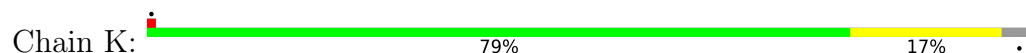
- Molecule 9: DNA-directed RNA polymerase II subunit RPB9



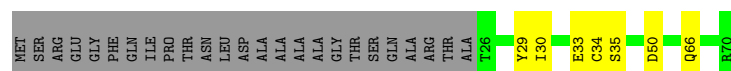
- Molecule 10: DNA-directed RNA polymerases I, II, and III subunit RPABC5



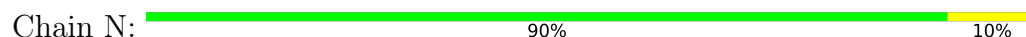
- Molecule 11: DNA-directed RNA polymerase II subunit RPB11



- Molecule 12: DNA-directed RNA polymerases I, II, and III subunit RPABC4



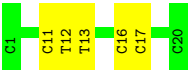

## 5 Model quality

### 5.1 Standard geometry

Bond lengths and bond angles in the following residue types are not validated in this section: MG, CPT, ZN

The Z score for a bond length (or angle) is the number of standard deviations the observed value is removed from the expected value. A bond length (or angle) with  $|Z| > 5$  is considered an outlier worth inspection. RMSZ is the root-mean-square of all Z scores of the bond lengths (or angles).

## 5.6 Ligand geometry [i](#)

Of 10 ligands modelled in this entry, 9 are monoatomic - leaving 1 for Mogul analysis.

In the following table, the Counts columns list the number of bonds (or angles) for which Mogul statistics could be retrieved, the number of bonds (or angles) that are observed in the model and the number of bonds (or angles) that are defined in the Chemical Component Dictionary. The Link column lists molecule types, if any, to which the group is linked. The Z score for a bond length (or angle) is the number of standard deviations the observed value is removed from the expected value. A bond length (or angle) with  $|Z| > 2$  is considered an outlier worth inspection. RMSZ is the root-mean-square of all Z scores of the bond lengths (or angles).

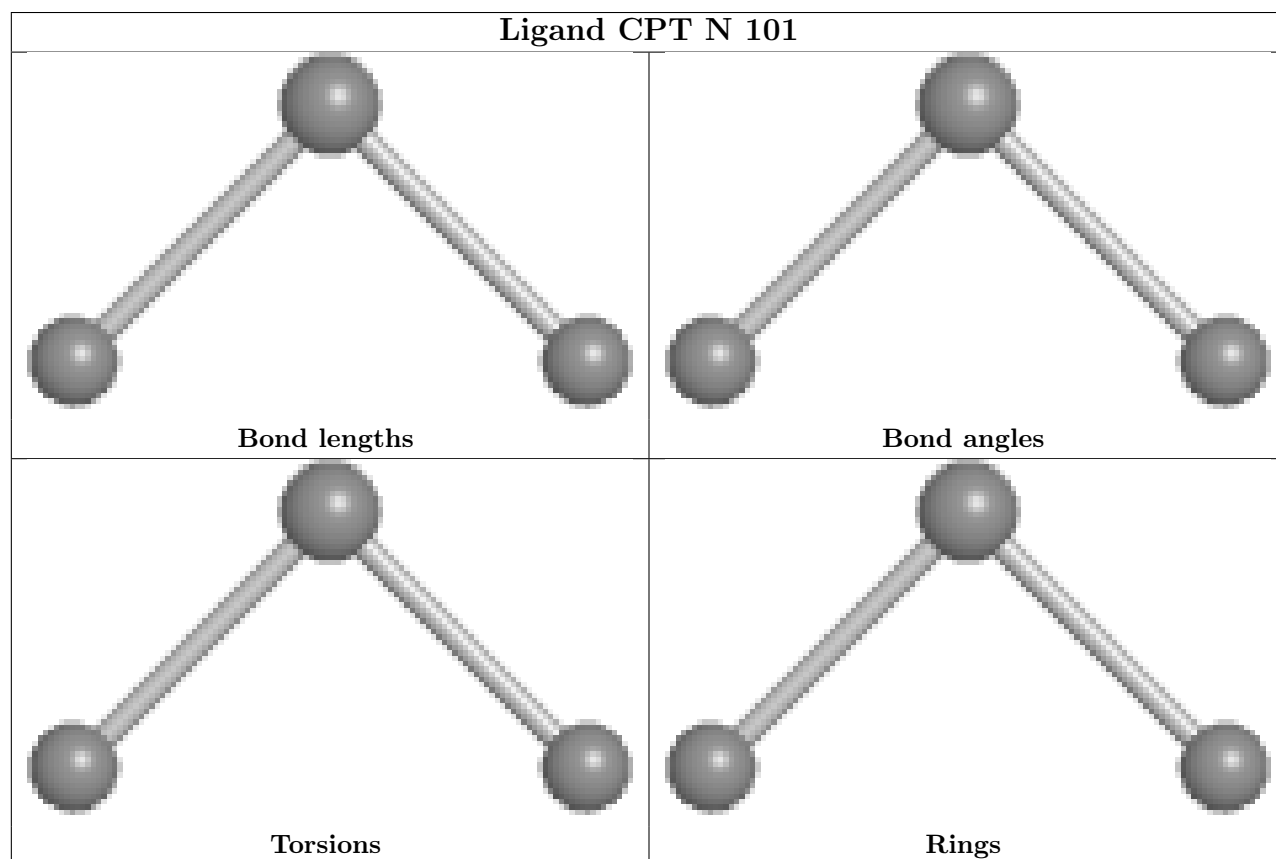

The following is a two-dimensional graphical depiction of Mogul quality analysis of bond lengths, bond angles, torsion angles, and ring geometry for all instances of the Ligand of Interest. In addition, ligands with molecular weight  $> 250$  and outliers as shown on the validation Tables will

also be included. For torsion angles, if less than 5% of the Mogul distribution of torsion angles is within 10 degrees of the torsion angle in question, then that torsion angle is considered an outlier. Any bond that is central to one or more torsion angles identified as an outlier by Mogul will be highlighted in the graph. For rings, the root-mean-square deviation (RMSD) between the ring in question and similar rings identified by Mogul is calculated over all ring torsion angles. If the average RMSD is greater than 60 degrees and the minimal RMSD between the ring in question and any Mogul-identified rings is also greater than 60 degrees, then that ring is considered an outlier. The outliers are highlighted in purple. The color gray indicates Mogul did not find sufficient equivalents in the CSD to analyse the geometry.

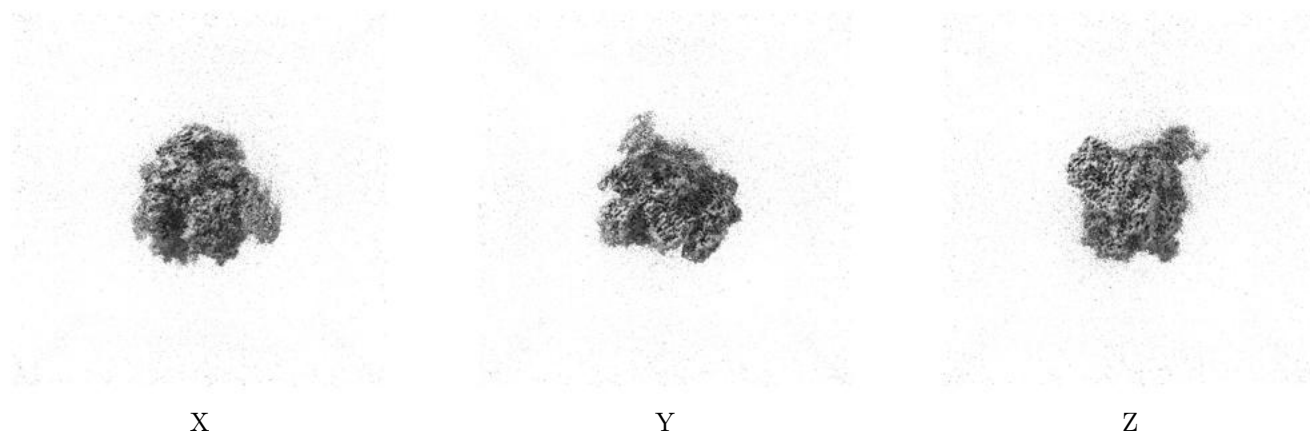

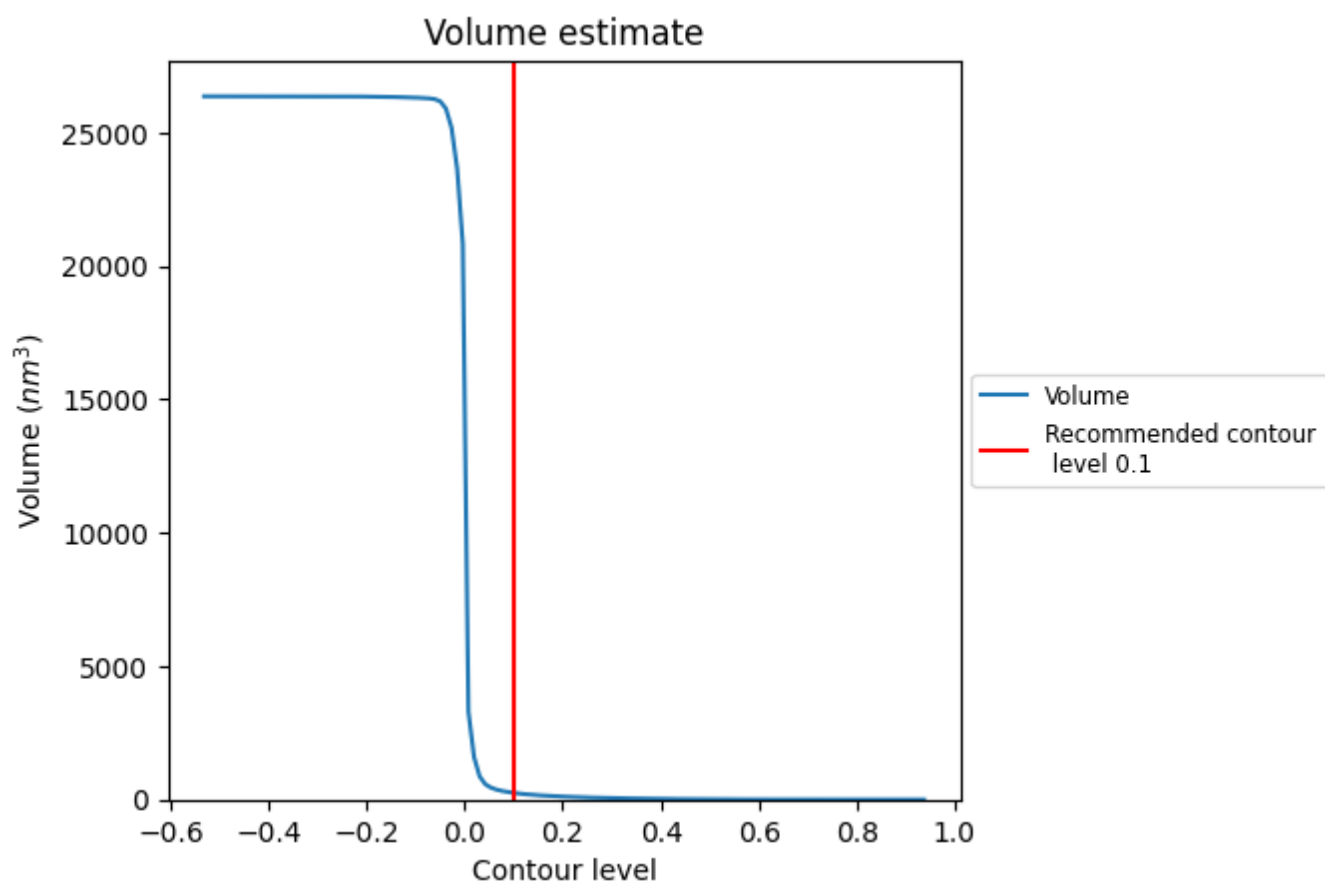

The map-value distribution is plotted in 128 intervals along the x-axis. The y-axis is logarithmic. A spike in this graph at zero usually indicates that the volume has been masked.

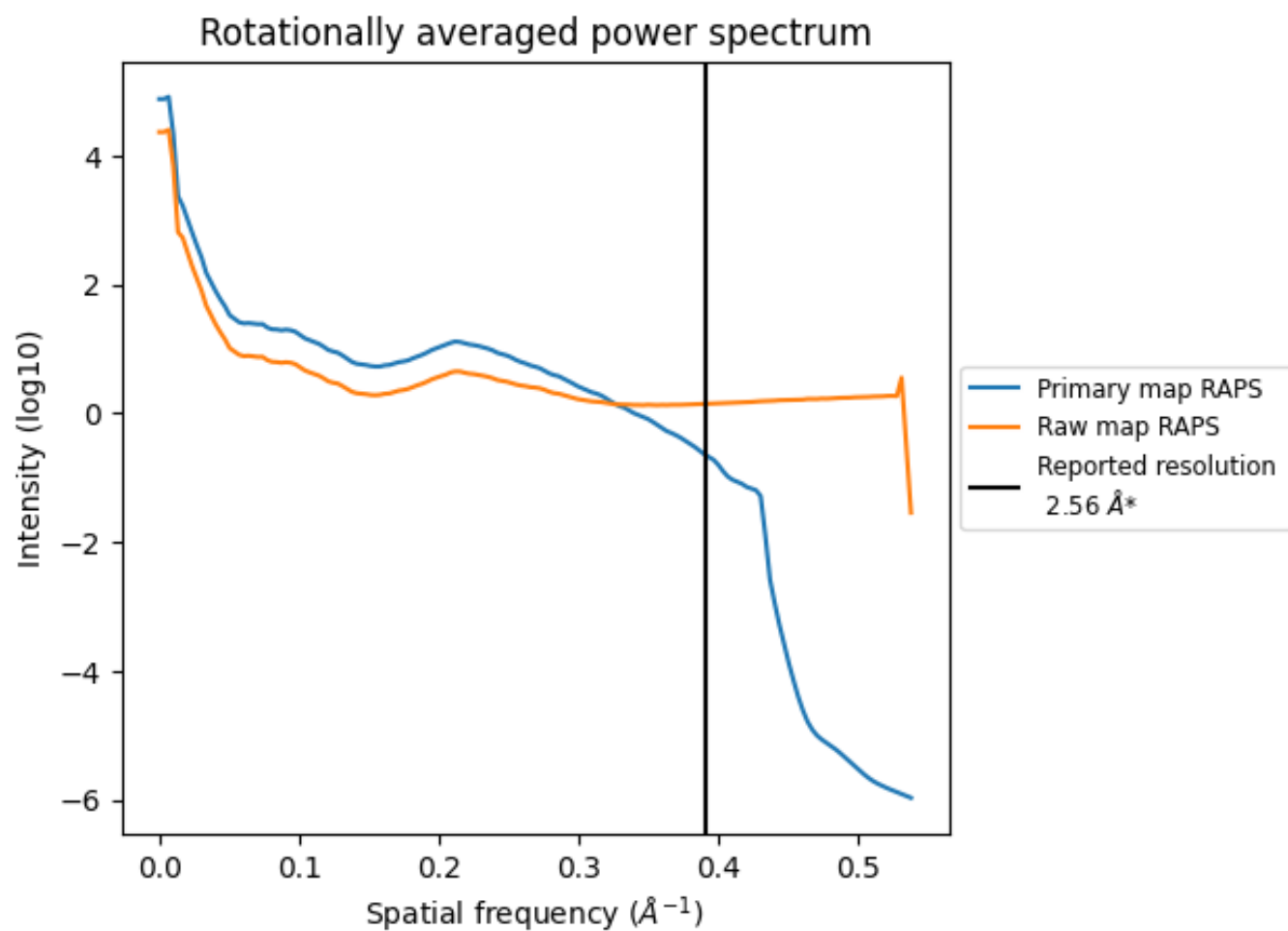
## 7.2 Volume estimate [i](#)



The volume at the recommended contour level is 249 nm<sup>3</sup>; this corresponds to an approximate mass of 225 kDa.

The volume estimate graph shows how the enclosed volume varies with the contour level. The recommended contour level is shown as a vertical line and the intersection between the line and the curve gives the volume of the enclosed surface at the given level.

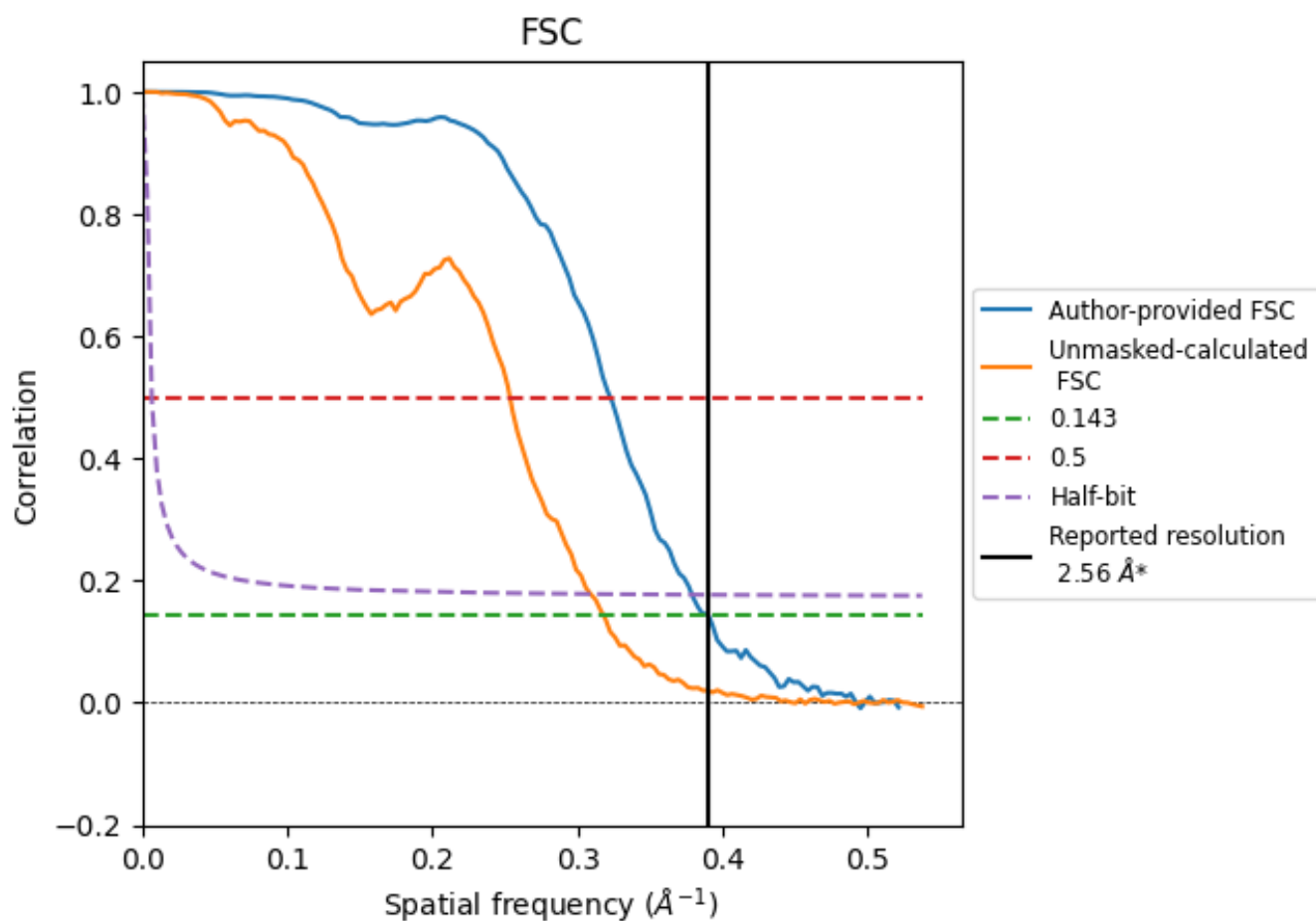

## 8 Fourier-Shell correlation [i](#)

Fourier-Shell Correlation (FSC) is the most commonly used method to estimate the resolution of single-particle and subtomogram-averaged maps. The shape of the curve depends on the imposed symmetry, mask and whether or not the two 3D reconstructions used were processed from a common reference. The reported resolution is shown as a black line. A curve is displayed for the half-bit criterion in addition to lines showing the 0.143 gold standard cut-off and 0.5 cut-off.

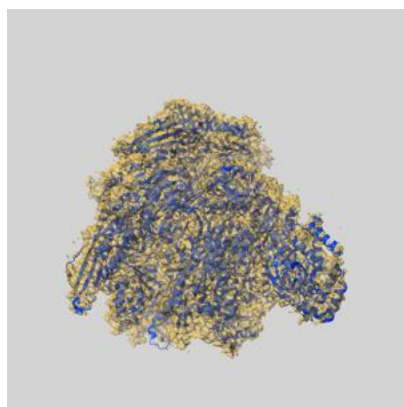

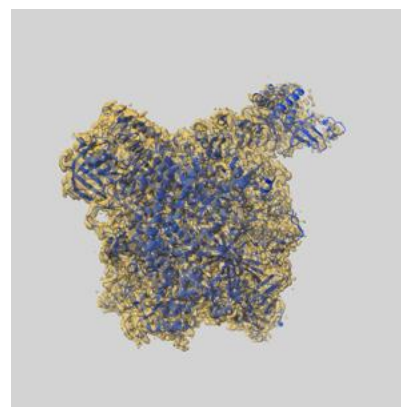

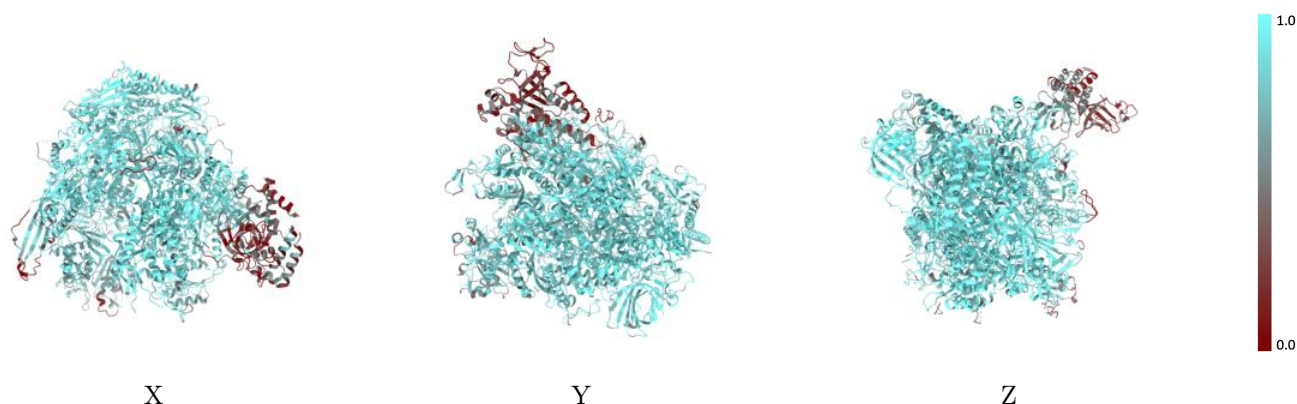

## 9.2 Q-score mapped to coordinate model [i](#)



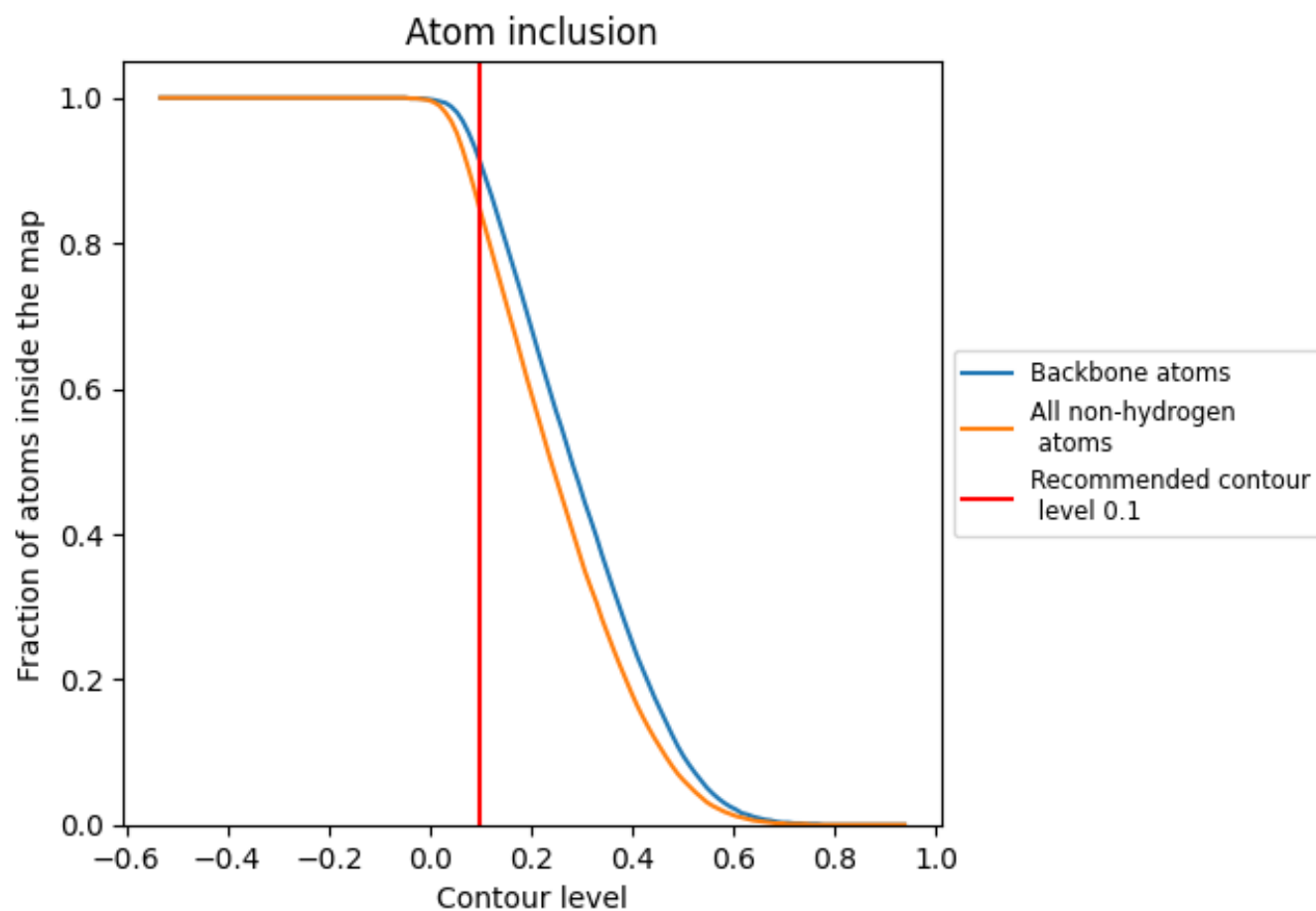
The images above show the model with each residue coloured according to its Q-score. This shows their resolvability in the map with higher Q-score values reflecting better resolvability. Please note: Q-score is calculating the resolvability of atoms, and thus high values are only expected at resolutions at which atoms can be resolved. Low Q-score values may therefore be expected for many entries.
